# Terms of Reference Minimum Operating Guidelines for PIF partners and Organizational Charter

## 1. Background

Women Association for Marginalized Women (WAM) is a prominent non-governmental organization located in Birendranagar-8 Aawas Chhetra, Surkhet, Nepal. Established in 1997 (2054 BS), WAM is dedicated to advancing the dignity, empowerment, and self-reliance of women. As a non-profit organization, WAM works to bridge the gap between men and women across social, economic, and cultural dimensions to promote an equitable society.

WAM focuses on empowering women through awareness activities addressing traditional beliefs, violence against women, gender and social discrimination, and social exclusion. By mobilizing local resources, WAM aims to empower women and establish effective partnerships with government, non-governmental organizations, and international agencies to achieve its goals.

#### 2. Overview

As a women's rights-based organization, WAM conducts various programs aimed at women's empowerment and social inclusion. Over the years, WAM has developed several policies and strategic plans. Currently, with funding from Oxfam Nepal's Partner Investment Fund (PIF), WAM is working on creating minimum operating guidelines for PIF partners and an organizational charter. This initiative, in collaboration with Bagmati Welfare Society Nepal (BWSN), is intended to enhance the capacity of the organization and align with PIF's objectives.

#### 3. Scope of Work

The consultancy firm or professional selected for this project will be responsible for the following tasks:

- Analyze current rules, guidelines, and other relevant documents to understand the internal context of Oxfam and its partner organizations.
- Create minimum operating guidelines for PIF partners and an organizational charter that align with PIF's objectives and standards.
- Conduct interviews and consultation meetings with internal and external stakeholders to gather input and perspectives.
- Perform an in-depth assessment of PIF partners' internal and external environments, including strengths, weaknesses, opportunities, and threats. This assessment will be part of a workshop for developing the guidelines.

- Facilitate workshops with key stakeholders from Oxfam and PIF partners to develop and refine the minimum operating guidelines and organizational charter.
- Documentation: Prepare the minimum operating guidelines and organizational charter in both English and Nepali.

# 4. Qualifications and Requirements

# Consultancy firms or professionals interested in this project must meet the following qualifications:

- At least a Master's degree in organizational management, social sciences, or a related field.
- Demonstrated experience in developing policies and guidelines for NGO/INGOs (experience with at least 2 NGOs required).
- Organizational Development: Experience in NGO organizational development.
- Strong command of the English language.
- Familiarity with the local context of Nepal, government policies, and priorities.
- Knowledge of gender and social inclusion issues and women's rights.
- Understanding of the minimum operating guidelines approach.
- Ability to conduct comprehensive assessments, facilitates participatory workshops, and produce high-quality guidelines documents.
- The firm must provide registration certificates, tax clearance, VAT, and PAN certificates with the application.

### 6. Application Process

- A detailed budget breakdown, consultancy fees and any additional costs.
